# 1. Call to Order

Chair Turner called the meeting to order, which was duly posted at 3:00 p.m.

## 2. Roll Call

Chair Turner led introductions; staff took roll call, and it was determined that a quorum of the Board was present.

### 3. Public Comment

There were no comments from the public. One member of the public was in attendance via telephone on Zoom for the beginning of the meeting. They left the meeting during Agenda Item 7 and no other members of the public joined the meeting.

### 4. Consent Agenda

Staff introduced the consent agenda. No public comment was made. Upon a motion duly made by Mr. Hunt and seconded by Mr. Harris, and with 4 affirmative votes, 0 no votes, and 1 abstention (Moggia), the Board approved the Consent Agenda, which approved the following items:

### 5. Comments from Endorsing Partners

A. Report from Endorsing Partner, California Special Districts Association (CSDA)

Mr. McCormick, Mr. Wood, and Ms. Strawn provided the Board with updates on their recent work to grow the Special District participant base in California CLASS and to educate prospective participants on the benefits of the investment product. No public comment was made.

### B. Report from Endorsing Partner, League of California Cities (Cal Cities)

Ms. Coleman provided a high-level overview of programs at Cal Cities and recent work to address public issues. Ms. Cadelago updated the Board on Cal Cities marketing initiatives and conferences. No public comment was made.

## B. Considering – Resolution No. 23-03 approving regular meeting schedule for Board of Trustees in 2024

Ms. Wohl presented the proposed regular meeting calendar dates for 2024. Upon a discussion from members, revisions were made to the suggested dates.

# C. Considering – Resolution No. 23-04 restricting funds to be held by Treasurer and waiving quarterly reporting obligations

Ms. Barnhill discussed resolution 23-04 and the restriction of funds held by the Treasurer. There were no comments from the Board. Upon a motion duly made by Mr. Harris and seconded by Mr. Clausnitzer, the Board unanimously adopted Resolution 23-04 (5-0).

## 7. Agency Business – Fund Management Reports

**Credit Research**– Mr. Matthes presented Public Trust Advisors' approved lists as of September 30, 2023.

**Fund Management** - Mr. Gebel presented to the Board an overview of the current economy as well as an update on the management of the California CLASS Prime fund. The sole member of the public in attendance left the meeting during this item. As a result, requests to take public comment were suspended for the remainder of the meeting.

## 8. Agency Business – Fund Administration Reports

## A. Sales and Distribution Update

Mr. Shull and Ms. Lynn presented the sales and distribution efforts of the California CLASS team, including new Participants, upcoming conferences, and the growth of the California CLASS Prime fund.





# **B.** Public Trust Updates

Mr. Starr discussed security enhancements that are being implemented on the California CLASS Participant portal, such as account change notifications, dual approval requirements, multifactor authentication, bank amendment form updates, caller authentication changes, and additional security measures to protect Participant accounts.

Mr. Tight and Mr. Starr discussed Public Trust's recent announcement that the firm had signed an agreement with a new capital partner. Mr. Tight reported the new partnership would provide for the continued evolution of Public Trust's organizational succession planning. The founding partners of Public Trust will remain involved in the business and all executive leadership and California CLASS personnel will remain consistent. Mr. Starr discussed the significant growth of Public Trust over the past decade and expressed that the new capital partners would be providing resources to assist in the further development of technology infrastructure and cybersecurity. In addition, the partnership will provide additional resources dedicated to new product development to better serve government clients nationwide. Following the Board's discussion, it was requested that staff provide updates to the Board with respect to the ongoing Public Trust client consent process. The Board determined they would discuss scheduling a special meeting during the administrative items portion of this meeting.

Mr. Rizzo notified Board members that the staff is working with its special legal counsel, Orrick, to update the California CLASS registration packet with additional security language.

Mr. Rizzo informed Board members that the California CLASS statement of facts / roster of public agencies filing with the Secretary of State has been updated to include Ms. Margaret Moggia given her recent reappointment to the California CLASS Board of Trustees.

## C. Administrative Items

Ms. Wohl informed the Board of recent marketing materials that have been electronically distributed to California CLASS Participants since the last Board meeting, as well as the location of updated marketing collateral for Board members to reference and use.

Ms. Wohl notified the Board that the California CLASS brand has been trademarked, and that an official certificate of registration has been received. The trademark is valid for 10 years.

Ms. Wohl reviewed the 2023 Board Budget and reported that the Trustee, accounting, and insurance year-to-date figures are tracking within budget. Legal expenses are above budget, due to additional work required for a new public agency, and it is suggested that this line item be increased by \$10,000 in the 2024 Board Budget.

Ms. Barnhill opened the discussion for the scheduling of a Special meeting of the Board before year end, to allow the Board to consider authorizing consent to have Public Trust Advisors move forward with a new capital partner. Upon a discussion





from members, it was determined that the Special Meeting of the California CLASS Board will be held at 11:00 a.m. on Monday, December 18 at the offices of Cal Cities, 1400 K Street, Suite 400, Sacramento, CA 95814.

# 9. Discussion / Information Items

### A. Enhanced Cash

Mr. Tight discussed plans to have a soft launch of the Enhanced Cash portfolio during the next three to six months. Additionally, staff plans to have educational meetings in the coming months for Participants about the nature of the investment product.

Mr. Clausnitzer requested that a Closed Session of the Board be added to the January meeting agenda for members to conduct an annual review of service providers. Mr. Hunt requested a presentation at the next regular meeting on the onboarding process of new Participants, specifically communications and education provided to Special Districts.

Mr. Harris discussed his participation and speaking engagements at recent conferences, and prospective California CLASS participants. Additionally, he thanked staff for their work to prioritize cybersecurity and safeguarding the California CLASS funds.

Ms. Moggia expressed her appreciation to be back on the California CLASS Board of Trustees. Additionally, Ms. Moggia brought attention to the great work that CSDA is doing for California CLASS.

### **RESOLUTION NO. 23-05**

# RESOLUTION AUTHORIZING AN ASSIGNMENT UNDER THE INVESTMENT ADVISOR SERVICES AGREEMENT

WHEREAS, on June 17, 2022, the California Cooperative Liquid Assets Securities System ("California CLASS") entered into a Program Administrative and Investment Advisor Services Agreement (the "Investment Agreement") with Public Trust Advisors, LLC ("Public Trust") to appoint Public Trust as the Investment Advisor and the Administrator for California CLASS;

**WHEREAS,** pursuant to the Investment Agreement, Public Trust will act as Investment Advisor and Administrator to effectively manage the California CLASS Investment Program;

**WHEREAS**, pursuant to Section 16 of the Investment Agreement, Public Trust must obtain the written consent of California CLASS before approving any assignment or delegation of Public Trust's obligations as Investment Advisor or Administrator;

**WHEREAS**, on September 18, 2023, Public Trust entered into a definitive agreement (the "Purchase Agreement") to recapitalize the firm with Flexpoint Ford LLC ("Flexpoint Ford");

**WHEREAS**, pursuant to the Investment Advisers Act of 1940, Flexpoint Ford's acquisition of a controlling interest in Public Trust would constitute an "assignment" of Public Trust's obligations under the Investment Agreement;

**WHEREAS**, on October 10, 2023, California CLASS received a letter from Public Trust explaining that California CLASS's consent is required for the Purchase Agreement with Flexpoint Ford to be finalized. Public Trust respectfully requested the consent of California CLASS;

**WHEREAS**, at the October 19, 2023 regular meeting, the Board considered Public Trust's request, including the additional resources Flexpoint Ford would provide to Public Trust that would assist in further product development and would enhance their technology infrastructure and cybersecurity; and

WHEREAS, California CLASS desires to accept the assignment of Public Trust, in the manner specified below.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Trustees of the California CLASS hereby resolves as follows:

- 1. <u>Recitals</u>. The Board of Trustees hereby finds and determines that the foregoing recitals are true and correct; the recitals are hereby incorporated by this reference as though fully set forth herein.
- 2. <u>Approval.</u> The Board of Trustees hereby approves the Consent to Assignment Agreement, subject to minor modification by the Board President in consultation with General Counsel.

- 3. <u>Implementation</u>. The Board of Trustees hereby authorizes the Board President to take such actions as may be necessary and appropriate to implement the purposes of this Resolution.
- 4. <u>Effective Date</u>. This Resolution shall become effective immediately upon its passage and adoption.
