1. Call to Order

Chair Turner called the meeting to order, which was duly posted at 3:02 p.m.

2. Roll Call

Chair Turner led introductions; staff took roll call, and it was determined that a quorum of the Board was present.

3. Public Comment

There were no comments from the public. No members of the public were in attendance either in person or via Zoom for the duration of the meeting. For this reason, these minutes will not reflect any public comments on the individual agenda items.

4. Consent Agenda

Upon motion duly made by Mr. Clausnitzer and seconded by Mr. Harris, and by unanimous vote (4-0), the Board approved the Consent Agenda, which approved the following items:

5. Comments from Endorsing Partners

A. Report from Endorsing Partner, California Special Districts Association (CSDA)

Mr. McCormick discussed the 2024 CSDA marketing activities and initiatives, including publications, speaking engagements, and collaboration with the Public Trust Advisors Distribution and Marketing teams. Mr. Wood discussed the year end audit and final meetings held during the 2023 fiscal year. Additionally, he noted upcoming workshops and conferences the association is attending and featuring California CLASS.

B. Report from Endorsing Partner, League of California Cities (Cal Cities)

Ms. de Jong discussed Cal Cities fiscal year end activities as well as new year membership renewals and initiatives. Cal Cities is working closely with the Public Trust Distribution team on innovative marketing ideas to engage new California CLASS Participants.

Ms. Cadelago updated the Board about new communications channels on the Cal Cities website designed to reach and educate more members about California CLASS. Cal Cities will be hosting the annual conference in September and is beginning to source speakers and sponsorships.





6. Board of Trustee Action Items

A. Appointment of Board Secretary

Chair Turner opened discussion for the Board to appoint a Board Secretary to serve a one-year term. Upon a motion made by Mr. Clausnitzer and seconded by Chair Turner, and by unanimous vote (4-0), the Board appointed Ms. Moggia to serve as the Board Secretary of California CLASS.

B. Considering – California CLASS Enhanced Cash Investment Policy Amendments

Mr. Tight reviewed recommended amendments to the Enhanced Cash Investment Policy eligible investments. Upon a motion made by Mr. Harris and seconded by Chair Turner, and by unanimous vote (4-0), the Board approved the California CLASS Enhanced Cash Investment Policy Amendments.

C. Considering - California CLASS Enhanced Cash Information Statement Amendments

Mr. Tight reviewed recommended amendments to the risk language in the Enhanced Cash Information Statement. Upon a motion made by Ms. Moggia and seconded by Mr. Harris, and by unanimous vote (4-0), the Board approved the California CLASS Enhanced Cash Information Statement Amendments.

7. Agency Business – Fund Management Reports

Credit Research – Mr. Berents presented the Public Trust Advisors' (PTA) approved lists for 2023 and discussed with the Board some of the more recent credit analysis that has been conducted by PTA, including additions and deletions to the approved lists.

Fund Management – Mr. Waud presented to the Board an overview of the current economy as well as an update on the management of the California CLASS Prime fund.

8. Agency Business – Fund Administration Reports

A. Sales and Distribution Update

Mr. Shull formally introduced Mr. Jerry Legg as the new Senior Director of Investment Services at Public Trust Advisors. Mr. Legg will work alongside Mr. Shull and Ms. Lynn on the California CLASS sales and distribution team. Mr. Shull and Ms. Lynn reviewed the California CLASS Participant list, prospect list, recent meetings, marketing efforts and the 2024 Conference Calendar. Mr. Legg updated Trustees on his first few months in his new role.





B. Public Trust Update

Mr. Tight provided an update on Public Trust Advisors recently completed transaction with the new capital partner Flexpoint Ford.

C. Legal Counsel

Ms. Barnhill reviewed the Form 700 submission protocols and timeline. Additionally, Ms. Barnhill updated the Board on recent communications with the Fair Political Practices Commission in response to the filing of the California CLASS conflict of interest code.

D. Board & General Administrative Updates

Ms. Wohl reviewed the audit timeline with the Board and noted the requirement for the California CLASS audited financials to be signed and filed with California CLASS within ninety days after the March 31st fiscal year end. Upon a discussion of the Board, it was determined that a special meeting of the California CLASS Board will be held on June 27, 2024 at 3pm in northern California.

The Board discussed the 2024 Board meeting calendar. The regular meeting scheduled for July 11 will be cancelled since the Board will be holding a special meeting two weeks earlier on June 27.

Ms. Wohl reviewed the 2024 Board budget; including an increased budget for legal services and decreased budget for insurance and auditing services.

The Board was provided with a copy of the 2024 certificate of insurance.

A. Enhanced Cash Portfolio

Mr. Rizzo presented the California CLASS Enhanced Cash investment product and discussed the process staff will take to introduce the product to California CLASS Participants. Board members discussed the California CLASS Enhanced Cash product and suggested methods of educating California CLASS Participants about the new investment option.

B. Board Vacancy

Staff brought forward potential Board candidates for the Trustees' consideration. Upon a discussion, Board members requested staff reach out to a candidate, and that staff continue working with the subcommittee to review candidates that may be brought forward to the Board for consideration.

C. Ad Hoc Strategy Committee

Upon discussion the Board determined that the Ad Hoc Committee formed in 2023 served its purpose, will be dissolved, and may be reformed when a special project requires a new committee.
