1. Call to Order

Chair Turner called the meeting, which was duly posted, to order at 3:00 p.m.

2. Roll Call

Chair Turner led the introductions, and the staff took the roll call. It was determined that a quorum of the Board was present, as noted above.

3. Public Comment

One public member, Lauren Warrem, was in attendance and briefly introduced herself to the Board. There were no additional comments from the public. Public comment was opened on each agenda item, but no members of the public chose to participate.

4. Board of Trustees Consent Agenda

Staff introduced the consent agenda. No public comment was made. Upon motion duly made by Ms. Moggia and seconded by Mr. Harris, and by unanimous vote (5-0), the Board approved the Consent Agenda, which approved the following items:

5. Comments from Sponsors

A. Report from Endorsing Partner, California Special Districts Association (CSDA)

Mr. McCormick discussed CSDA membership, which has almost reached 14,000 members and includes approximately 60% of special districts in California. He also updated the Board on general operations, budget planning, and the event schedule for the remainder of 2024. Ms. Strawn discussed recent marketing initiatives and exposure to the California CLASS brand at the CSDA annual conference. Mr. Wood updated the Board on recent district meetings and efforts to help special districts understand their investment options.

B. Report from Endorsing Partner, League of California Cities (Cal Cities)

Ms. Coleman updated the Board on Cal Cities' growing membership and items that will be discussed at their upcoming Board meeting. She also noted that Cal Cities will be hosting the annual conference in Long Beach from October 16-18 and expects record attendance. Ms. Cadelago added details about the Annual Conference and California CLASS's sponsorship. Additionally, Ms. Cadelago updated the Board on the Cal Cities magazine and future opportunities where California CLASS may be featured.

6. Board of Trustee Action Items

A. Oath of Office

Ms. Barnhill administered, and Mr. Phillips declared the Oath of Office. The Trustees welcomed him to the Board and thanked him for his service.





B. Election of Officers

Ms. Barnhill introduced this item. The Board agreed that the Board Treasurer would not hold any funds, consistent with the previously adopted Resolution to this effect. Chair Turner expressed support for there to be a rotation among Trustees in the officer positions and nominated Mr. Clausnitzer to be Chair. Mr. Clausnitzer nominated Mr. Harris to be Vice Chair. Mr. Harris nominated Ms. Moggia to be Treasurer and Ms. Moggia nominated Mr. Phillips to be Secretary. Upon a motion duly made by Mr. Phillips and seconded by Ms. Moggia, the Board unanimously approved (5-0) the following officers of the Board of Trustees:

C. Considering – Taking Action on signing a letter of consent authorizing Public Trust Advisors to complete a transaction agreement to merge business with another firm

Mr. Tight provided an overview of Public Trust's continued growth and the recent success of the firm's capital partnership with FlexPoint Ford. More recently, the Public Trust team has been working on a merger with a similarly structured firm with a longstanding and successful track record servicing local governments nationally. Public Trust staff provided the Board with an assignment letter to provide consent to the merger as necessary before the closing of the transaction. The Board asked questions about timing, the interplay of business in other states where both entities have existing LGIPs, and challenges.

Mr. Clausnitzer provided a motion authorizing Christina Turner, Chair of California CLASS, to sign the letter consenting to Public Trust Advisors' merger with PMA. Mr. Phillips seconded the motion, which the Board unanimously approved (5-0).

D. Considering – Adoption of Resolution No. 24-01 approving regular meeting schedule for Board of Trustees in 2025

Ms. Wohl opened the discussion for the Board to select regular meeting calendar dates for 2025. Consistent with prior practices, the meetings will be held across the state to facilitate public access. The specific meeting location for the upcoming Regular meeting will be announced on the agenda of the current agenda. Upon a motion duly made by Mr. Harris and seconded by Mr. Phillips, the Board unanimously approved Resolution 24-01 (5-0) the following 2025 regular meeting schedule:

E. Considering - Readoption of Conflict of Interest Code

Ms. Barnhill reviewed the recommendation that the Board of Trustees readopt a Conflict of Interest Code to govern which California CLASS staff and consultants must file Form 700s. The Code, previously adopted on April 21, 2023, was submitted to the Fair Political Practices Commission (FPPC). No changes have been made to the Code.

Upon a motion duly made by Mr. Harris and seconded by Mr. Phillips, the Board unanimously (5-0) readopted the Conflict of Interest Code.

7. Agency Business – Fund Management Reports

A. Credit Research

Public Trust Advisors Senior Credit Analyst Taylor Budrow provided updates and recent changes to the California CLASS approved lists.

B. Economic Update

Mr. Waud, Chief Investment Officer, provided the Board with an overview of the current economy. He discussed the September Federal Open Market Committee meeting, which resulted in a half-point interest rate cut, marking the first rate reduction since March 2020, lowering the federal funds rate to 4.75%-5.0%. This larger-than-expected cut signals the Fed's focus on balancing inflation, which has moderated, with labor market concerns, as unemployment has remained above 4% for the past four months. Chairman Powell has set expectations that further half-point reductions are unlikely as the Fed aims to achieve a soft economic landing. Nevertheless, this is subject to change in light of new information.

C. Fund Management Report

Mr. Waud gave the Board an overview of the current portfolio strategy and highlighted the composition of California CLASS. He also discussed the launch of the California CLASS Edge product and the importance of educating Participants interested in the product about floating NAV. California CLASS's objectives will always be safety, liquidity, and yield. California CLASS places an emphasis on providing a secure, modern platform and insightful information to its participants.

8. Agency Business - Administration Reports

A. Sales and Distribution

Mr. Shull presented the current California CLASS Participants and balances. He also discussed the prospect list and reviewed the list of conferences California CLASS will be sponsoring and attending for the remainder of 2024. Ms. Lynn discussed referral resources and highlights from her attendance at recent Fire District conferences. Mr. Legg updated the Board about recent and upcoming meetings with Participants and prospects. The team continues to focus on providing great

Mr. Tight discussed Public Trust Advisors' business plan and timeline for integrating Public Trust after the transaction closes this month, specifically new technology and new products.

Ms. Wohl shared the new Board member onboarding checklist with the Board and noted that she and Ms. Barnhill would work to complete Mr. Phillips onboarding in the coming months.

Ms. Wohl reviewed the current Board of Trustees budget. Additional expenses have been included and will be shown at all future meetings to ensure that the Administrator provides a detailed accounting of expenses to the Trustees at least quarterly, as outlined in Section 11.1 of the JPA.

Ms. Wohl noted that the Marketing Team at Public Trust is working on the annual Participant survey.

9. Discussion Items

A. California CLASS Strategic Plan Development

Ms. Moggia opened a discussion for the Board to develop a strategic plan and process to establish goals, values, and alignment on California CLASS's growth and direction. The Board discussed strategic planning meetings they had participated in within their participant entities and agreed that creating a strategic framework for California CLASS would be beneficial. Chair Turner designated Ms. Moggia and Mr. Clausnitzer to serve on the newly formed ad hoc Strategic Plan Subcommittee, with a mission to help specify a strategic framework for California CLASS's future, which would be formed for approximately one year, meet as needed, and disband upon the Board taking action on the Strategic Plan.
